As this advocate was going over the OP process and current procedure the FJC is following to file an OP she inquired about her having to go to court and stated that she does not want to go to court or ever see the suspect again. Advocate explained court would be part of the process for not only the OP but also the criminal process. Advocate went over and safety planed with the victim regarding the conditions of release for the suspect and provided information for the DA's office. Kelli Spears stated that she feel she needs to proceed with filing the OP because when she was notified of the suspect being released from jail she was fearful and locked her bedroom door and was very afraid because the suspect has lost his job and she knows how much he loved his job. During the conversation with Kelli Spears it was apparent that this was not the first physical incident, and she stated that she does not know what he is capable of. Victim plans to come to the FJC 4/3/2020 at 0900.
