Commissioner Anders moved to initiate a Sector Plan Amendment for the apartments on the front, and, in the context of that, MPC is to review that as a whole; and to hold the rezoning until the Sector Plan Amendment comes back. Commissioner Jay seconded the motion.

Commissioner Smith moved as a substitute motion to refer the item back to MPC for a Sector Plan Amendment to change the 19 acres from Low Density Residential to High Density Residential; and to change the zoning on the remaining 51 acres to 4 ½ units per acre for Planned Residential. Commissioner Jay seconded the motion and upon roll call vote Commissioners Busler, Wright, Dailey, Jay, Biggs, Carringer, Smith, Nystrom and Anders voted aye. Commissioners Gill and Schoonmaker voted no. The substitute motion carried 9-2-0-0. Property located southeast side Westland Drive, northeast of Heritage Lake Way. (Commission District 5) MPC's file number: 8-E-18-RZ.

The following resolution regarding this matter was drafted by the Knox County Law Department and reads as follows:
