Commissioner Anders moved to approve Ordinance O-19-11-101 -Ordinance of the Commission of Knox County, Tennessee, amending the Knox County Code, Appendix A – Zoning, Article 2, Section 2.20 – Specific terms, Article 5, Section 5.38.03 – Uses permitted on review, and Article 4 to add a new Section 4.106 – Standards for the use-on-review approval of microbreweries in the CN Neighborhood Commercial district and Subsection 4.106.01 – Minimum requirements, to define microbreweries and identify them as a use subject to use on review approval in the CN Neighborhood Commercial district (amends Ordinance O-90-9-130, adopted September 10, 1990) on first reading.
