RECOMMENDATIONS

The following are items that were discussed during the KCSO/MC Special Called Committee that we believe warrant additional attention and resolve but remain outside the purview of the Knox County Commission. As the Chairman of the Special Committee, I would encourage all parties to take special attention to address these matters. If improvements can be made in these areas, we believe it will help with officer recruitment, morale, and retention.

OFFICER COMPENSATION

Throughout the work of the special called committee, the topic of officer compensation came up many times. Discussions were plentiful around the need for higher pay across the force including incentives and bonuses for special training, educational achievements, court time, retention milestones, benefits, classification, etc. Additionally, there seems to be a strong desire for all elements of compensation to be codified in writing and fully transparent to all to reduce any possibility of favoritism or inconsistent promotions. Regardless of the various elements, it remains clear that all decisions concerning compensation lies entirely in the purview of the Sheriff.

RECRUITMENT, PROMOTIONS & TRANSFERS

Currently, the process for recruiting and promoting officers begins with filling positions within the detention facility. In order to build a more dynamic and fluid workforce, it is recommended that the KCSO embrace lateral transfers from outside the KCSO and recruit specifically for corrections without the assumption of promotion outside that line of work. Additionally, the workforce would benefit from having clear, defined career pathways and promotions to eliminate favoritism, real or perceived.

COMMUNICATION

Many of the hurdles to building a productive working relationship between the Sheriff's office administration and the Merit System Council team seemed attributed to the need for improved communications. It is recommended that both parties hold regular monthly meetings and agree upon a standard set of reporting tools that can be easily tracked and measured. This data could then be standardized into monthly and quarterly reports to ensure all parties are on the same page. Additionally, a recommendation was shared to have weekly Captain and Command Staff meetings to eliminate silos of information across the force.

HUMAN RESOURCE MODERNIZATION

The process the KCSO and MC follow for accepting applications and onboarding candidates is severely dated which causes unnecessary delays and often leads to miscommunication. It is recommended that both parties work with the Knox County Human Resources department to source and implement a modern software platform that can track recruiting process while providing a shared, transparent set of information that will be more efficient and effective.

FEEDBACK / OFFICER SURVEYS

One recommendation related to improved retention efforts was to create an anonymous method for exit surveys. When members of the force resign or retire, it is imperative for the Sheriff's Office administration understand why. Although there are some exit survey functions in place, turning this process into a truly anonymous platform will ensure candid and better quality feedback to use when improving the overall employment environment.

ENGAGEMENT W/COUNTY COMMISSION

As determined by the Knox County Law Department, the Merit System and its Council fall under the purview of the Knox County Commission. It is recommended that the Merit System team provide quarterly presentations to Commission, work with the Commission to review the ordinance annually, and when appropriate, make recommendations to Commission for further consideration. If there can be a more engaged relationship between both parties, improvements for the officers will certainly follow.

Commissioner Beeler seconded the motion and upon roll call vote Commissioners Smith, Ward, Schoonmaker, Hill, Busler, Beeler, Dailey and Biggs voted aye. Commissioners Lundy, Durrett and Jay voted no. The motion carried 8-3-0-0.
