### **Be Part of the Solution**

### **Common Sense Precautions**

- Do not burn within 50 feet of any structure
- Do not burn near landfills
- **Do not** burn near streams or sinkholes
- Do not burn near utility lines
- · Do not burn on windy days
- **Do not** burn without fire extinguishing equipment present
- **Do not** leave fire unattended

## **Alternatives to Open Burning**

### Reduce, Reuse and Recycle

- Carry a coffee mug with you instead of disposable cups.
- Donate old clothes, shoes, books, appliances, electronics, furniture and toys to charity.
- Take your own cloth bag to the store.
- Leaves and grass clippings can be composted to be turned into food for your garden or houseplants.
- Tie four wood pallets together to make a simple compost bin.
- Take plastic (1-7), cardboard, paper, aluminum, steel and glass to a Knox County or City of Knoxville recycling drop-off center.



### **Obtaining an Open Burning Permit**

Knox County residents may apply for an open burning permit to open burn brush wood at an established private residence, farming operation or established church congregational property online at www.knoxcounty.org/airquality/ or by calling 865-215-5900 between the hours of 8 a.m. and 4:30 p.m., Monday through Friday.

## Why is Open Burning Regulated?

Air pollution from open burning can cause serious health problems and damage the environment. When you burn trash, 7 to 9 percent of what you burn ends up as air pollution, and some pollutants are *highly toxic*. Pollutants include particulate matter, dioxin, heavy metals and arsenic among many others. What we burn today is different than what was burned in the past. Many items contain low levels of chlorine, that when burned release a pollutant called **dioxin**, a toxic chemical.

Dioxins are dangerous at extremely low levels and have been linked to cancer and other serious health problems. The EPA has shown that open burning of garbage is the nation's largest source of non-industrial dioxin emissions.

Dioxins from open burning end up in our water and soil. They accumulate in animal tissue and enter our food supply, especially when we consume meat and dairy products.

# **Legal Open Burning**



# Open burning which requires a permit:

Land management on an established private residence, farming operation, or established church congregational property (on-site only)

- An open burning permit shall be received prior to and maintained on-site during open burning
- Only brush wood (of which no part may exceed three (3) inches in diameter) grown on that property is burned
- Only between the hours of 9 a.m. to 3 p.m. (all flames extinguished by 4 p.m.)
- Materials burned in piles not exceeding 144 ft³

Other open burning as approved by the director where there is no other practical, safe and/or lawful method of disposal

- An open burning permit shall be received prior to and maintained on-site during open burning
- Adhere to conditions on the permit



#### **Cooking Fires**

#### **Recreational/Ceremonial Fires**

- Campfires
- Ceremonial bonfires

#### **Construction Site Warming Fires**

- Fire contained in a suitable metal container
- Only untreated wood is burned
- Only when air temperature is 45°F or below

### **RESTRICTIONS**

#### **Department Open Burning Ban**

During adverse meteorological or weather conditions, and on "air pollution action days," all issued open burning permits shall be invalid and no open burning allowed. Call the number on the permit each day prior to burning, to learn if a ban is in place.

### **City of Knoxville Area**

Open burning of solid waste, including yard waste, within Knoxville city limits is expressly prohibited by City Ordinance Section 13-8.
