#### HOLD HARMLESS CLAUSE

The permittee shall indemnify, defend, release, save, and hold harmless Knox County, Tennessee, its officers, agents, and employees from any and all suits, claims, actions, liability, or damages of any nature whatsoever brought because of, arising out of, or due to the use or occupancy of the park facility by the permittee, a member of the organization, any person in attendance, or any third party based upon negligence, premises liability, violations of local, state, or federal law, or under any other theory whatsoever.

The permittee hereby agrees that it will be responsible for the proper use of the park facility or section of the park facility indicated above and that if there are any damages to the park facility occurring from this use, the permittee will be responsible for reimbursing Knox County, Tennessee for any costs resulting from those damages. The permittee also agrees to pay the Parks and Recreation Department's associated fee(s). As the authorized representative, I state that I have hereby read the rules and regulations of Knox County Parks and Recreation regarding the use of the park facility or section of the park facility indicated above and confirm that the permittee will follow those rules and regulations.
