IN RE: CALL TO ORDER

Chairman Caldwell presided and called the meeting to order.

IN RE: AMENDMENTS TO AGENDA

Chairman Caldwell reported that there were no amendments to the agenda.

IN RE: APPROVAL OF MINUTES OF DECEMBER 19, 2022

The motion was seconded by Ms. Samar. All members present voted in favor. The motion passed unanimously.

IN RE: REPORT OF EXECUTIVE DIRECTOR

- <u>Election Update</u> Ms. Schroeder stated that there were 5 petitions requested. 3 petitions were for the County and 2 petitions were for the Sheriff's department. IT did online sampling for election purposes.
- <u>USI Quarterly Statements</u> Ms. Schroeder reported on a feature on the USI website allowing a
 participant to elect to have an email in lieu of mailed quarterly statement. Once elected, a notification
 will be emailed to the participant that statements are available online.
- Valuation Update Ms. Schroeder reported that the valuation will be sent to USI by the end of the week.
- Plan Summaries through 12/31/2022 Ms. Schroeder presented the second quarter plan summaries.

IN RE: REPORT OF INVESTMENT COMMITTEE

• <u>Monthly Rates of Return</u> – Mr. Simons presented the rates of return for the Defined Contribution and Defined Benefit Plans and stated the overall rates of return are in line with respective markets.

IN RE: REPORT OF LEGAL COUNSEL

Mr. Owings had no report.

Ms. Trotto reported that SECURE Act 2.0 was passed December 29, 2022. She summarized significant immediately effective provisions, including (1) the increase in RMD commencement age from 72 to 73, (2) removal of the first day of the month rule for 457 Plan elections, and (3) the ability to rely on participant "self-certification" of hardship. She noted that other changes, including various in-service distribution options, will be discussed in more detail at an upcoming Document Committee meeting. Plan amendments are not required until 2027.
